A. **Administration** – The transition to UKG for Human Resources and payroll software is moving along well. Insurance enrollment and benefit plans will be added to the system soon.

- B. **Recreation** Thank you for the facility agreements for summer camps. On the coming Saturday there will be a wheelchair basketball fundraiser at Timothy Christian High School to support IHSA and tournament participation.
- C. Staffing and Support Services They are implementing a new applicant tracking and hiring system. 18 staff members have been hired in the past few months. Staff is going out to schools and getting in front of students for recruitment. Inclusion statistics are in the packet. WD surveyed families in the fall. There were 17 responses and almost all gave a 5 on a scale of 1-5. We are doing a ton of training, including park district staff. Rec & Roll currently has 336 registrations and the anticipation is that will increase. 14 Timothy Christian students came out in the beginning of January to spend six days working with Rec & Roll program. Currently reaching out to Timothy Christian to volunteer at swim meets.
- **D. Foundation** Annual Appeal funds raised was \$78.050, down from the previous year with 13 fewer donors. Thank you for your Bash support. All things point to a very successful Bash. Sponsorship is up from 25 to 36 total sponsors. Raise the Paddle will be for a scholarship endowment. Intending to fill the Development Manager position in April.
