There are still 2 openings in Athletics and 2 in Inclusion. Inclusion may not be filled until fall. At Special Olympics Team Illinois took the gold medal in flag football. We had 2 participants on the team and Phil Eide was the Defensive Coordinator. Thanks to the Board for their support of the golf outing. A big shout out to Lea and her team for their fundraising efforts.

## VIII. NEW BUSINESS

### A. Member Assessment Request 2023:

The first draft of the Member Assessment Request was distributed for review to be voted on in August. All member district's EAVs increased slightly and at a lower rate than anticipated. Leahy asked for board discussion and guidance on strategies to make up the loss of revenue with a reduced EAV. Options include tapping into reserves, Districts picking up more of the Inclusion cost, or increasing the .02 out of .04 of taxes collected. Benard felt that the use of reserves is the first option and right way to go. With the effects of inflation on expenses, the reserves would have to be monitored. Leahy stated that the Board had asked about the intentional spend down of the reserves. Tapping into the reserves

for operational costs would delay other projects. Pawlowski suggested that a Finance Task Force be considered. Pawlowski, Wilson, Reinbold and Benard all agreed to serve on the Task Force.

#### IX. STAFF REPORTS

# A. Recreation

- Adatto reviewed the end of year statistics which show a steady increase over the previous year.
   There has been a 54% increase in unique individuals registering for Inclusion and programs. Our participants are ready to come back and new families are signing up.
- Rec & Roll team and Program team are both fully staffed. Interviews are being conducted for Athletic Supervisors and one offer has been extended. 2 interns have been picking up a lot of projects for the teams.
- Camp started last week with a large scale return. Training was redesigned to give more support to staff. All extended school year camps are at school facilities.
- Congratulations to Phil Eide and Special Olympics Illinois. The games were a good spotlight for WDSRA and for the sports in general.

### B. Staffing and Support Services

- We have hired about 90 new support staff members bringing us close to the pre-Covid numbers.
- Inclusion is back to a normal summer with 1,070 registrations, 88% of pre-Covid. This includes a record setting number of new families coming to Inclusion.
- 2022 Staff awards were presented and are listed in the written report.

#### C. Foundation

- Thank you to everyone for their support of the Golf Outing. Net proceeds is about \$42,000. Golfers had a wonderful time despite mother nature.
- Stone Jewelers donated \$4,000 to WDSRA from their watch battery replacement program plus other donations.
- Exchange Club's Ribfest is this weekend at the Fairgrounds. Day program participants are doing set-up and a WDSRA team is serving beer on Friday.
- Shout out to Sherry Manschot for doing a great job of getting all our good news out on Social media.
- The Foundation has increased it's giving to WDSRA this year by \$25,000.
