This is a routine review conducted every 2 years. There are 3 small changes to approve. The policy has been reviewed by the auditors, our GFOA representative and the finance people from member

districts. There was a late suggestion to limit what an investing officer could invest. No interest was expressed to pursue that change.

B. Approve Personnel Policy changes. Pawlowski/Radun moved to accept the Personal Days Policy updates as presented. Motion passed unanimously with a voice vote.

The DEI committee discussed granting Juneteenth as a holiday but rather than close WDSRA they recommended rewarding an extra personal day to employees instead. Rec & Roll staff that works more than 25 hours or more per week are also given PTOs.

C. Approve Resolution 2022-01 Membership in PDRMA Health Program. Pawlowski/Reinbold moved to approve resolution 2022-01 Membership in PDRMA Health Program. Motion passed with a roll call vote.

- The Annual Appeal will start in November. We will be getting a match through Coleman Foundation of any donation of \$275 or higher, up to a total of \$12,500
- Planning for Bash 2023 is underway.
- Eblasts have been focusing on what donations have been used for.
